Description of first aid measures

Special protective equipment and precautions for firefighters

Protective equipment for fire-fighters

: Firefighters should wear an approved full-face, self-contained breathing apparatus (SCBA) and impervious clothing. SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

: Restrict access to area until completion of clean-up. Keep all other personnel upwind and away from the spill/release. Ensure clean-up is conducted by trained personnel only. All persons dealing with clean-up should wear the appropriate protective equipment including self-contained breathing apparatus. SECTION 7. HANDLING AND STORAGE

Precautions for safe handling

: Do not handle until all safety precautions have been read and understood. Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Simple asphyxiant - this product does not contain oxygen and may cause asphyxia in confined spaces. Oxygen content in the area must not fall below 19.5% or harmful effects will result.

Use only in well-ventilated areas. Avoid inhaling gas. Keep away from extreme heat and flame. Keep away from incompatibles. Protect cylinders from damage. Never attempt to lift cylinder by its cap. Open valves slowly to prevent rapid decompression. Shut flow off at cylinder valve and not just at the regulator after use. Use only with equipment rated for cylinder pressure. Do not puncture or incinerate containers.

Conditions for safe storage : Cylinders should be stored upright and firmly secured to prevent falling or being knocked over. Store in a cool, dry, well ventilated area, away from heat and ignition sources. Avoid storage of cylinders for more than six months. Do not store in direct sunlight. Protect from sunlight when ambient temperature exceeds 52°C/125°F. Storage area should be clearly identified, clear of obstruction and accessible only to trained and authorized personnel. Inspect periodically for damage or leaks.
